BD93E11GWL EVK Quick Start Guide

Introduction

The Document is the quick start guide of the BD93E11GWL EVK.

Overview of the EVK



The check list before the operation.


- 1. A jumper is on the JP_VIOSEL terminal.
- 2. A jumper is on the JP_STP terminal (Any positions are acceptable.)
- 3. A jumper is on the JP_OTP terminal (Any positions are acceptable.)
- 4. Each DIP switch, SW_VMAX, SW_VMIN, and SW_PMIN, shall have only one position. SW_VMAX is to position "8". SW_VMIN and SW_PMIN are to position "1" in each.

Note: An external power source is unnecessary due to supporting dead battery mode.

These DIP switches have the position of SW_VMAX=20V, SW_VMIN=5V, and SW_PMIN=0.5W in default to allow connecting to any PD sources. The setting indicates to accept the range from 5 to 20V, and the minimum operating power is 0.5W as the EVK requesting capability.



The blue range indicates PD contractable range as the sink, and the sink requests the maximum voltage and current that a connected PD source supports. Please see the EVK User's Guide or the Application note for further information.



The connection and operation

Prepare a Type-C/PD adapter in market and connect it to the EVK via a Type-C cable, then PD contracted voltage can be monitored by a digital multimeter.



Note that changing the configuration via each DIP switch requires the power cycle to be updated, so please disconnect the source device from EVK by removing a cable.
