



About Electrostatic Breakdown

LED products are classified as having a lower electrostatic breakage resistance than other semiconductor products. InGaN devices used in blue and white LEDs are more vulnerable to static electricity than other InGaAlP and GaP (red to yellow-green) devices. The following is an explanation of anti-static measures.

Electrostatic Breakdown Measures

To prevent electrostatic damage to the InGaN devices used in blue and white LEDs, we recommend installing Zener diodes in parallel to protect the LEDs.
