
Dynamic resistance (Z_Z) is measured by applying small current (AC) and specified current (I_Z) simultaneously.

Characteristic Curves












CAPACITANCE BETWEEN TERMINALS:C_t(pF)

Characteristic Curves





Precaution for Mounting / Circuit board design

- 1. When a highly active halogenous (chlorine, bromine, etc.) flux is used, the residue of flux may negatively affect product performance and reliability.
- 2. In principle, the reflow soldering method must be used on a surface-mount products, the flow soldering method must be used on a through hole mount products. If the flow soldering method is preferred on a surface-mount products, please consult with the ROHM representative in advance.
