






StructureSilicon Epitaxial Planar






POWER DISSIPATION:Pd(%)




CLAMPING VOLTAGE:Vcl(V)




CLAMPING VOLTAGE:VcI(V)





TRANSIENT THAERMAL IMPEDANCE:R<sub>th</sub>(°C/W)











