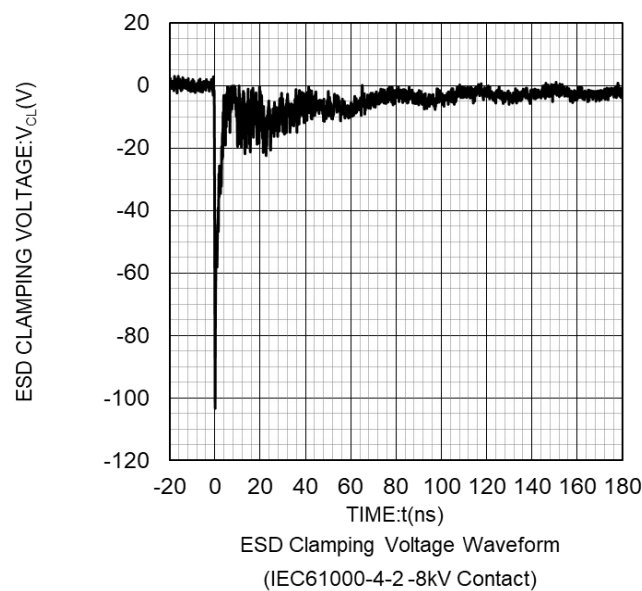

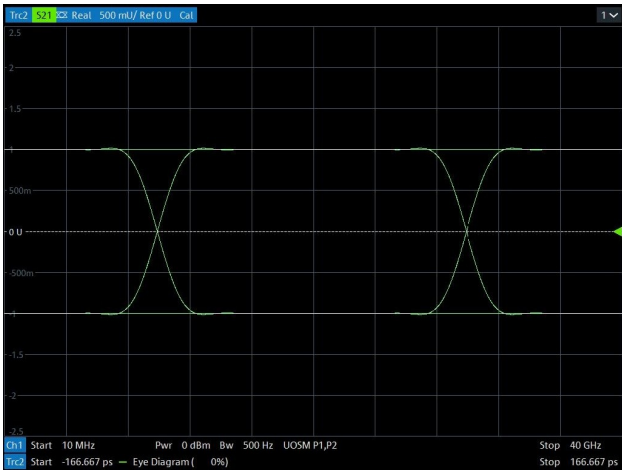
I-V characteristics for a bidirectional ESD protection diode



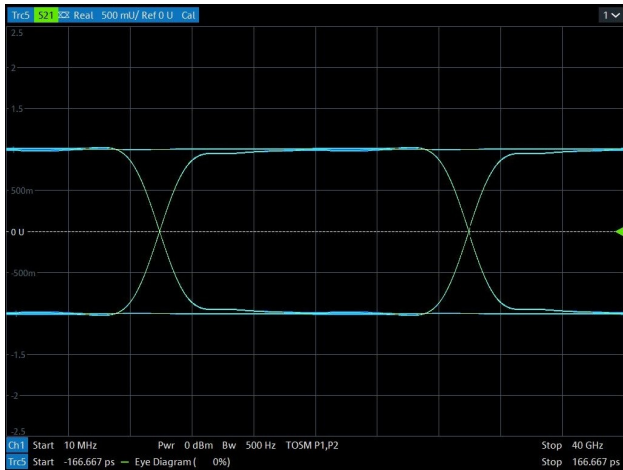

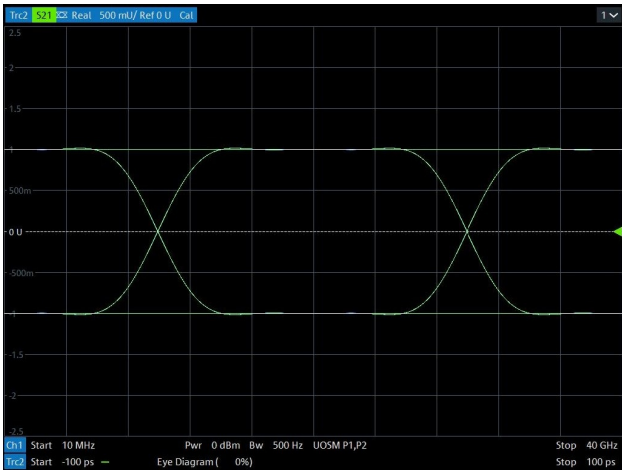

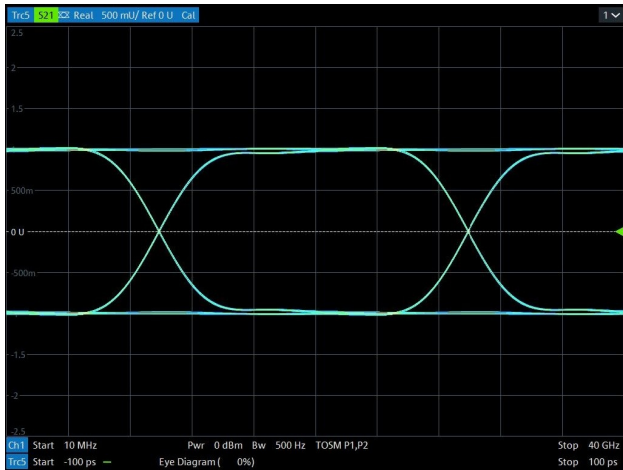
Data Rate > 6 Gbps Eye Diagram
(Bare board)



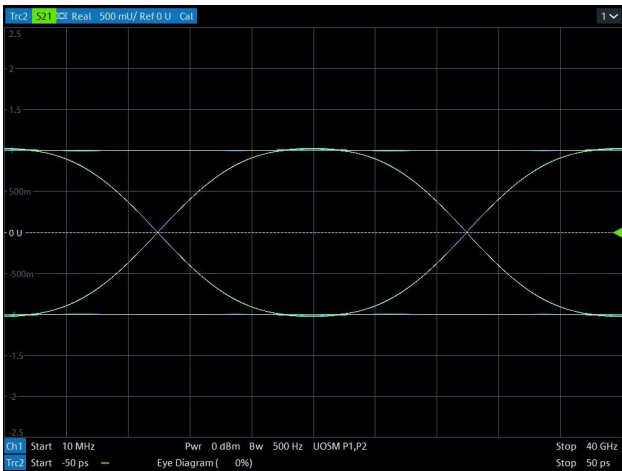
Data Rate > 6 Gbps Eye Diagram
(with RES3V3BAED)



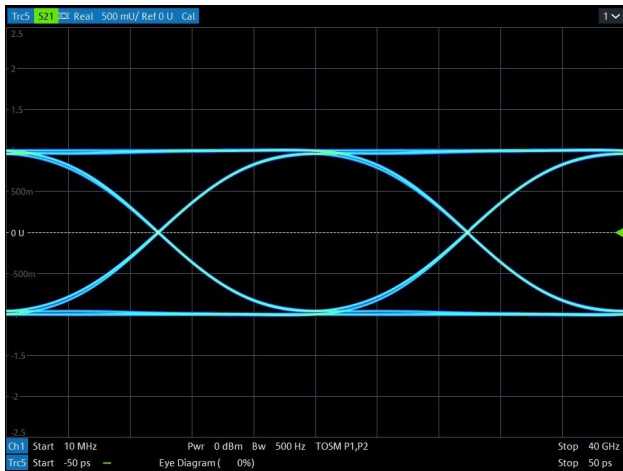
Data Rate > 10 Gbps Eye Diagram

(with RES3V3BAED)

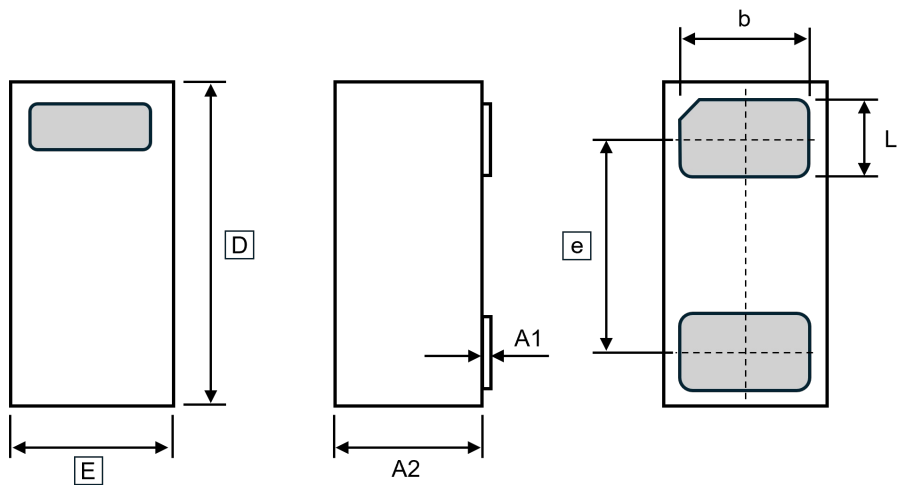


Data Rate > 20 Gbps Eye Diagram
(Bare board)



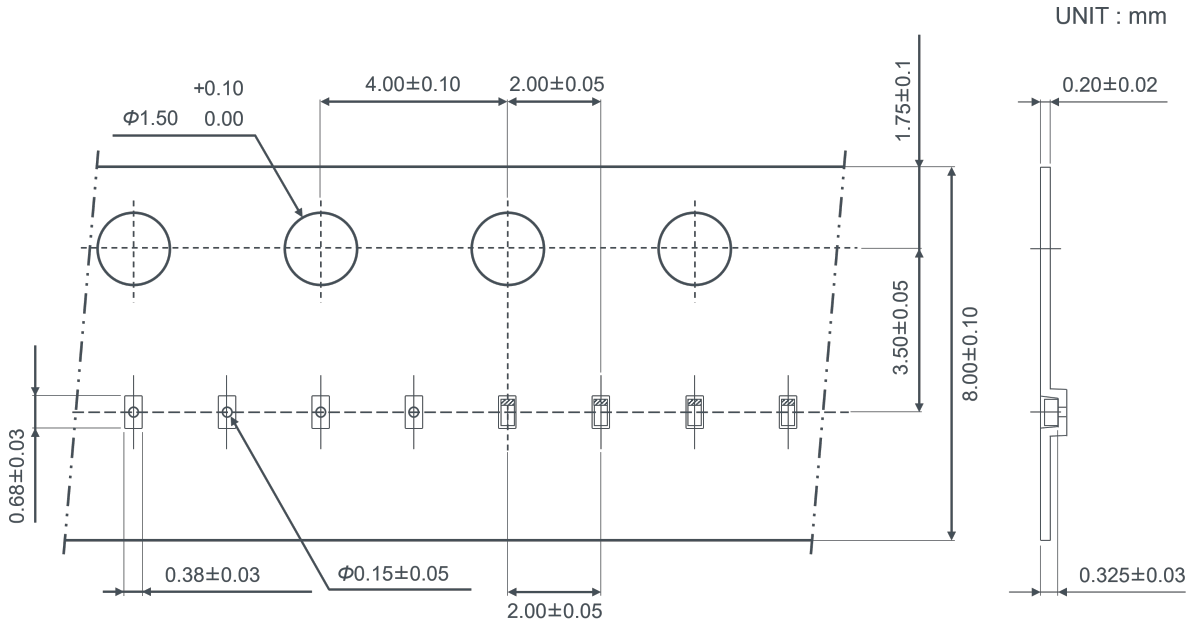
