


PEAK PULSE CURRENT: Ipp (A)












CAPACITANCE BETWEEN TERMINALS:C_i(pF)







IEC61000-4-2 Waveform






oscilloscope

Then, add the 10X-attenuator between test board and the cable to protect the oscilloscope.


4 Discharge ESD in contact discharge mode at any voltage. (normally 8kV Max.)


