






Fig.1 Power Dissipation Derating Curve






Fig.2 Drain Current Derating Curve




Fig.5 Breakdown Voltage vs. Junction Fig.6 Typical Transfer Characteristics




Fig.7 Gate Threshold Voltage vs. Junction Temperature






Fig.8 Forward Transfer Admittance vs. **Drain Current**






Fig.17 Typical Capacitance vs. Drain -Source Voltage

Fig.18 Switching Characteristics






Fig.19 Source Current vs. Source Drain Voltage


