


Markings on chip resistor

The description of markings on the chip resistor are as shown below.

Example of marking



① Marking method: There are three or four digits used for the calculation number according to IEC code and "R"is used for the decimal point.

Example: $3 \text{digits......} 10 \text{k}\Omega = 103$, $10\Omega = 100$

4digits.....10k Ω =1002, 10 Ω =10R0

2 Marking direction: Standard, Resistor surface marking.

3 Marking colors: Yellowish white marking or other appropriate marking

4 Forming method of marking: Screen printing
